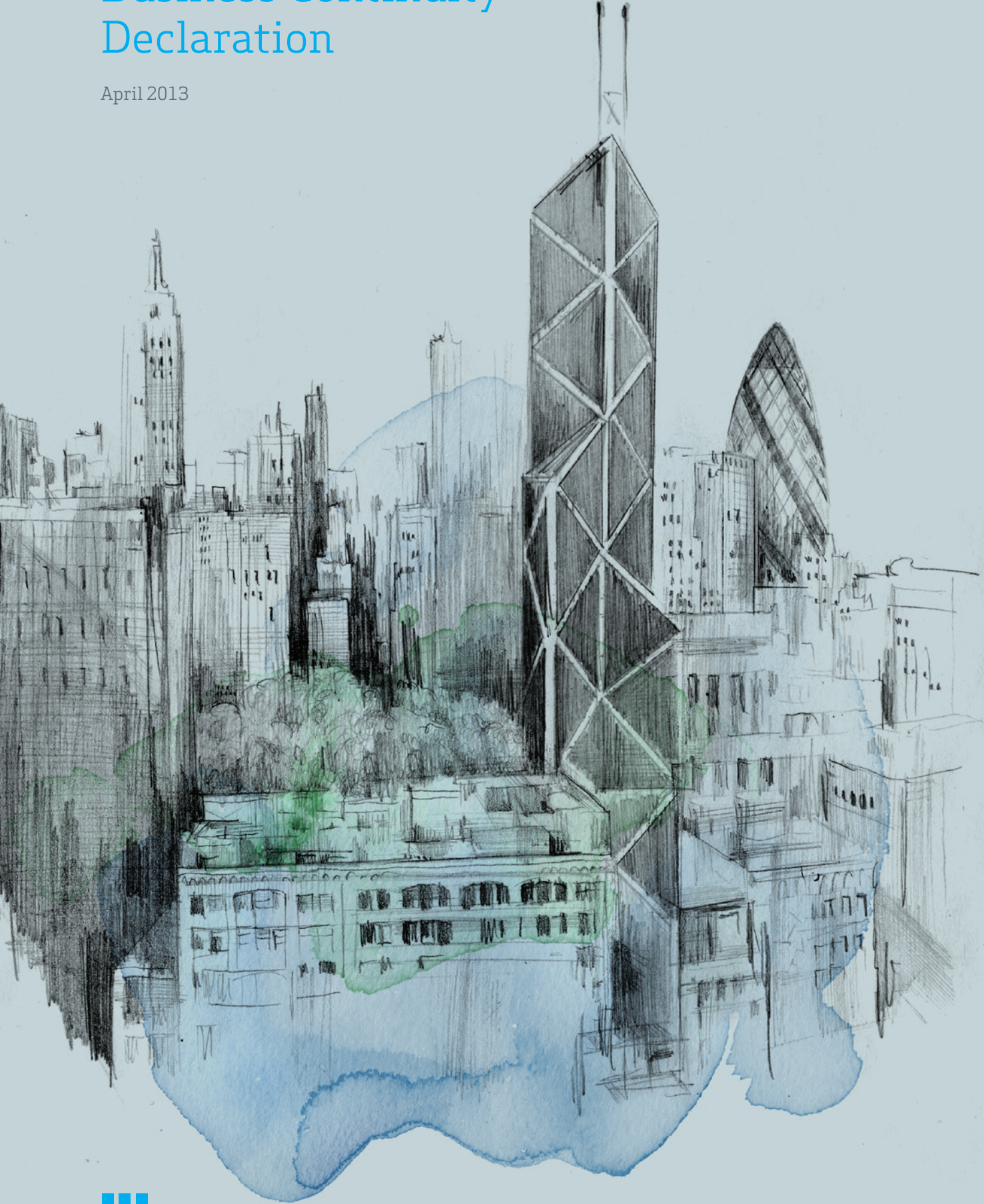


Business Continuity Declaration

Business Continuity Declaration

MVision Private Equity Advisers (MVision) has developed a Business Continuity Plan (Plan) that addresses how we will respond to events that significantly disrupt our business (Disasters). Our goal is to be able to continue to represent our Clients to the best of our ability during and after a Disaster, understanding that the timing and impact of any Disaster are unpredictable and that our Plan must necessarily be flexible.

Alternatively, we will leave instructions for Clients on Websites, on voice mail or using other means to provide access to us.

Protection of Documents and Data

We have adopted procedures for backing up electronic data and copying or protecting hard copies of documents that we believe are unique and/or critical to our business.

Business Continuity

Our Plan provides for notification to regulators, and contacts with our banks or other financial institutions with which we have relationships, so that we can continue to do business in the event of a Disaster. Although we believe that it is unlikely, if a Disaster is so severe that it prevents us from remaining in business, we will notify our Clients as soon as possible and return to them materials in our possession, if any, that belong to them.
